ADDITIONAL VENDOR INFORMATION

- The 2 4 1 Walk planning team will determine the location for each exhibitor's space. Any locations determined prior to the event day may be changed or altered on the day of the event, by event staff. We will use reasonable efforts to honor placement requests where possible, based upon availability.
- Exhibitors are responsible for any permits and insurance related to the activity provided at their booths or related to any item being sold.
- No water connections or electrical connections are provided at exhibitor booths.
- You may not "sublet" your booth space in whole or part. You are not allowed to share your booth with another company or organization, unless approved by Early Alert Canines in advance of the event date.
- Any exhibitor causing damage to the event venue or other property provided or used in conjunction with the event, shall be responsible for the cost of the damage.
- Exhibitors are responsible for securing all money and items in their booth.
- You agree that all dogs brought to the event must be leashed (No retractable leads) or crated. No exceptions. Dogs may not show signs of aggression. Violations will result in removal of vendor and dogs from the event.
- Exhibitors are responsible for cleaning up their booth area after the event; the grounds should be left clean and in the same condition they were in upon arrival.
- If supplied, exhibitors must return all tables, chairs and other supplies in working order and free of damage at the end of the event.
- If any of the terms and conditions set forth in this Booth Application, Regulations and Agreement are not followed, Early Alert Canines may refuse to allow your continued participation in this event and future events.
- Please be aware that firearms, alcohol, and open flames are prohibited. The sale of products of services is not permitted at our event without prior approval and permission. On or offsite animal adoptions or promotions of adoptions are not allowed.

CANCELLATION / REFUND POLICY

- Exhibitors who cancel on or before 9/12/19 will receive a refund of one-half (1/2) the total fee paid.
- Exhibitors who cancel after 9/12/19, those who sign up and pay after this date and decide to then cancel, or those who do not show up for the event will not be entitled to any refund.
